CLUB CREDIT SALE

Purchase club credit anytime now through December 31, 2011, and save 10% in 2012. You may purchase club credit in \$100 increments for \$90, and they will be applied to your account for use anytime in 2012. Purchase your annual cart pass before 12/31, and you can purchase it for just \$500 + tax instead of the full price of \$575.

Club credits may be used for food and beverage purchases, cart rental, or taking a friend golfing. If you plan on using a golf cart, enjoying a delicious meal or just a casual beverage or two, then why not save money while having fun.

You may use your credit at the Club beginning in 2012. Credit may be purchased at the Club, by mail, or even over the phone using a credit card. Club Credit may not be used to pay sales tax on cart pass.

Referring members must be paid members in good standing during calendar 2012. Club Credit for a new member referral must be requested at the time the new member joins, and used by September 1, 2012.
